3. 2025 City-Wide Speed Survey – California Assembly Bill 43 (AB43)

City Engineer Tipping, Associate Engineer Ramos, and Advantec Consultant, John Dorado, gave a PowerPoint presentation and addressed Commissioners' questions regarding the 2025 City-Wide Speed Survey, California Assembly Bill 43 (AB43), implementation and compliance and the Manual on Uniform Traffic Control Devices (MUTCD).

Chair Stump invited public comment.

Commission Secretary Ramirez announced two written public comments were received and uploaded to the archived document system.

<u>Douglas Lyon, Claremont resident</u>, urged the Commission to reconsider implementing the suggested reduced speed limits in the City from the 2025 City-Wide Speed Survey, citing excessive regulations and arbitrary justifications.

There were no other requests to speak.

Vice Chair Weiner asked if the Speed Survey was conducted with a peer city, and if the Police Commission would be reviewing the Speed Survey prior to going to the City Council.

Advantec Consultant Dorado addressed Vice Chair Weiner's concerns regarding the survey, and City Engineer Tipping explained that the Police Commission does not review the Speed Survey.

Commissioner Arya asked if the same materials provided to the Commission would be provided to City Council. He requested that more information be provided to address the Commission's concerns regarding the four ten-mile-per-hour reduction zones.

City Engineer Tipping addressed Commissioner Arya's concerns for more detailed information by providing an explanation on the preparation process for the Speed Survey book.

City Engineer Tipping also addressed Mr. Lyon's concerns regarding the Speed Survey being arbitrary. She cited the City's use of 85<sup>th</sup> percentile and AB43's provisions.

Chair Stump and Commissioner Ramos expressed apprehension regarding the enforcement of the speed reductions.

Commissioner Arya moved that the Traffic and Transportation Commission review the recommended speed limit modifications and recommend that the City Council adopt through local ordinance, the updated speed limit zones evaluated on the 2025 Citywide Speed Survey, thereby, maintaining the existing posted speed limits or lowering the speed limits in certain roadways, as recommended; seconded by Commissioner Weiner, and carried on a vote as follows:
