2. Sign Review #24-S03 for Proposed Revisions to Existing Signs and Sign program at the Claremont Depot, 200 West First Street – Applicant: Claremont Lewis Museum of Art

Assistant Planner Jordan Goose gave a PowerPoint presentation.

Principal Planner Chris Veirs addressed Commissioners' concerns regarding banners, light boxes, style consistency between signs and building, sign maintenance, and signage at the back side of the museum.

Chair Neiuber invited the Applicant to make a presentation.

Martin Betz, Executive Director of the Claremont Lewis Museum of Art, commented on the considerations that went into designing the historic building's signs.

<u>John Bohn, Project Architect,</u> discussed the history of the building, the museum, and the sign program. He addressed Commissioners' concerns for child safety.

Chair Neiuber invited public comment.

There were no requests to speak.

Commissioner Bennett thinks there is signage overload, and that banners obscure historic elements; but the signs at the sidewalks and entrances are good and helpful

Commissioner Zimmerman addressed some child safety issues but supports the project.

Commissioner Spivack spoke about the lightboxes, what worked and what did not, and thinks the banners should be smaller. Overall, she supports the proposal.

Vice Chair Castillo understands the need for ten-foot lightboxes but thinks the banners should be smaller. She supports the proposal.

Chair Neiuber thinks banner size should be reduced; the height of the light boxes is appropriate; and current exhibit signs should be freestanding. He supports the sign program proposal.

Principal Planner Veirs advised the Commission on the wording of the motion.

Adopt Resolution No. 2024-09, A RESOLUTION OF THE ARCHITECTURAL AND PRESERVATION COMMISSION OF THE CITY OF CLAREMONT, CALIFORNIA, APPROVING SIGN REVIEW FILE #24-S03, FOR PROPOSED REVISIONS TO EXISTNG SIGNS, APPROVAL OF A REVISED SIGN PROGRAM INCLUDING UP TO FIVE NEW SIGNS, APPROVAL OF TEMPORARY LIGHT POLE-MOUNTED BANNERS, AND REPLACEMENT OF AN EXISTING MONUMENT SIGN, AND APPROVING A SIGN VARIANCE TO ALLOW ADDITIONAL HEIGHT FOR TWO NEW SIGN CASES INCLUDED IN THE REVISED SIGN PROGRAM, AT THE CLAREMONT DEPOT. LOCATED AT 200 WEST FIRST STREET; and

 Final Review of Revised Conceptual Site Plan for the Claremont Colleges East Campus, To Be Renamed The Roberts Campus East Sports Bowl – Applicant: Claremont McKenna College (#23-A02)

Principal Planner Veirs gave a PowerPoint presentation that recapped the project, and summarized revisions that had been made since the preliminary review (April 24, 2024).

During the EIR section of his presentation Principal Planner Veirs introduced <u>Michael Houlihan</u>, <u>Principal Associate at Environmental Science Associates (ESA)</u>, and <u>Doug Gordon-Blackwood</u>, ESA Biologist.

Chair Neiuber invited the Applicant to give a presentation.

<u>Matthew Bibbens, Vice President for Campus Planning and Capital Projects at Claremont McKenna College (CMC)</u> discussed water management issues, the revised elevation of the football field, and lighting.

<u>Aaron Coakley, Project Manager from Bjarke Ingels Group (BIG)</u>, discussed project design, phasing, and developments since the April APC meeting.

Chair Neiuber invited public comment.

Administrative Assistant Bennett reported that no written general public comment had been received on this Item. Principal Planner Veirs received a supportive call from an Upland resident. Also, the Applicant requesting revisions to the Resolution.

Elizabeth Willis, <u>Elizabeth Willis</u>, <u>General Manager of the Chino Basin Water Conservation</u>
<u>District</u>, spoke about CMC field elevations and water management.

<u>Kevin Sabicer, Upland resident,</u> has concerns about sidewalks and bike lanes on Monte Vista Avenue (in Upland), noise, lights, unhoused people, security, and fences.

Commissioner Spivack had no comments.

Commissioner Bennett likes the revised plan and thinks it is a great project.

Commissioner Zimmerman thinks this is an excellent project. He wants cross-sectional visualizations in plans, with light specs. He supports the project.

Vice Chair Castillo likes the revisions that were made, and the overall design. She wants cross-sectional visualizations with lighting specs in plans. She is in support of the project.

Chair Neiuber thinks this revision is a big improvement. He noted that this is a conceptual plan, details about lighting and buildings will be addressed in the future.

Principal Planner Veirs advised the Commission regarding how to word the motion for the "as revised" resolution, as per the Applicant's revisions.
