I am a renter in Claremont, writing in opposition to the Short-Term Rental Ordinance. Short-term rentals have proliferated across Southern California and negatively impacted nearby cities. According to the National Low Income Housing Coalition, the fair market rent for a two-bedroom home is \$2,100, meaning a household would have to earn more than \$40/hour to afford to house their family. Short-term rentals are likely contributing to these high housing costs. According to a 2022 report by Professor David Wachsmuth of McGill University, in Los Angeles, short-term rentals have contributed to an average increase of \$810 on rents since 2015.

I am worried that similar effects will occur in Claremont if we repeal our City's ban on short-term rentals. Renters like me deserve to be able to live in our communities without the fear of being pushed out by operators trying to extract as much profit as possible from our homes. A position statement to the Claremont City
Council from 'Housing Claremont.' April 24,

2025. Respectfully Submitted by Rev. Gene Boutilier, President, The Housing and Homeless Collaborative of Claremont.

We know there is serious community harm caused by un-hosted commercial 'vacation' short-term rentals(such as 'AirBnB.') A compromise is in order and so we support the final adoption of the current draft Claremont city ordinance you voted for at midnight on April 22, which creates a pilot program for a limited number of hosted Short-Term Rentals, after a 6-year-long struggling process to establish a workable policy and program. We thank you for the effort put into this process.

- -To underregulate, which is the current practice, by forbidding all short-term rentals, but hardly at all enforcing the rules, is a bad choice. It creates confusion, invites the current exploitative proliferation of un-licensed short -term rentals and overall disrespect for civic authority, law and order.
- -To overregulate and prevent resident homeowners from income and hospitality, by not allowing reasonable amounts of regulated hosted home-sharing with relatives and guests, is a bad choice. (Hosted, meaning the property owner is a real person who actually lives on the property, and following detailed regulations, including parking requirements, occupancy limits, code compliance, and other guard-rails, is permitted to short-term rent either an ADU or main home.)
- -But the worst bad choice is giving in to pressures and slipping into a regulatory abyss that allows the commercial short-term rental industry to move wholesale into our beloved Claremont.
- § They will decrease the availability of affordable long-term housing by converting residential units

into tourist accommodations.

§ They will therefore lead to higher rents and home prices.

§ They will contribute to gentrification, displacing long-term, lower-income residents.

§ They will erode neighborhood diversity, community and social fabric.

§ They will disrupt neighborhood stability.

§ They will alienate residents as local businesses cater more to upscale tourists than to middle and working class and us fixed-income elderly local residents.

§ They will cause party-related harms, disruption, litter, illegal parking.

§ If taxed less than hotels they will lower local revenue for schools, infrastructure, and public services.

Keep the vacation rental mini-hotel industry out of our neighborhoods, while permitting regulated, limited, fee-paying, small-scale local-hosted house-sharing in Claremont's privately owned residential dwellings.

The best housing policy remains to affirmatively promote using all our houses and available properties for many more real homes for real neighbors of all income levels.
