Mayor Calaycay reported that he and Councilmember Medina represented the City in Guanajuato, Mexico to officially reinstate the City's Sister City relationship.

Councilmember Medina further reported on his travels and meetings that took place at the City's Sister City, Guanajuato, Mexico.

#### **CITY MANAGER REPORT**

City Manager Pirrie reminded all that City offices will be closed Wednesday at 12:00 PM and will reopen Monday, December 1 in observance of the Thanksgiving holiday, trash collection will be delayed, and overnight parking restrictions will be waived Thanksgiving night. He also reported on upcoming City events taking place in December.

## **PUBLIC COMMENT**

City Clerk Desautels announced no general written public comment had been received.

Mayor Calaycay invited public comment.

<u>Evvaggelos Vallianatos, Claremont resident,</u> expressed concerns regarding the Claremont Helen Renwick Library charging for room rentals.

<u>Natalie Sweiss</u>, <u>Marigold Coffee Collective</u>, asked the City Council to allow all vendors to remain at the Farmers Market until the conditions of the existing Farmers Market permit are amended to address the non-compete clause and allow prepared food vendors.

<u>Sylva</u> spoke in support of mobile businesses and shared how mobile businesses positively impact the community.

<u>Asher Sweiss</u> spoke about Marigold Coffee and the financial impacts to the business if not allowed to participate in the Farmers Market.

<u>Issa</u> spoke in support of Marigold Coffee and highlighted negative impacts if the Farmers Market permit is not amended. He spoke about a community petition that included over 130 signatures in support of prepared food vendors at the Farmers Market.

<u>Samanta De La Cruz, Pack a Bowl Acai,</u> spoke in support of allowing prepared food vendors at the Farmers Market.

Renee, Beignet booth owner, spoke in support of allowing prepared food vendors at the Farmers Market.

<u>Barnabus Path</u> spoke about Katie Gerecke and the positive impacts she made on the Claremont community.

<u>Brian, Claremont resident,</u> asked the City Council to be transparent in its decision regarding the Farmers Market.

<u>Unidentified speaker</u> spoke about the poor condition and frequent loitering at the public restroom outside the Council Chamber, the proposed overnight parking program at the Claremont United Church of Christ, and asked the City Council to support the Claremont Homeless Advocacy Program in restarting its program.

<u>Unidentified speaker</u> highlighted the negative impacts due to the increase in homelessness issues taking place in and around the Claremont village.

<u>Lydia Hernandez</u>, <u>Claremont Tenants United</u>, questioned why the City's surplus funds were not dedicated to renter assistance, why the City refuses to enact a rental registry, and why the City has not enacted a rent cap.

As it has been over 30 minutes, the time set aside for general public comment, Mayor Calaycay announced public comment would be continued to later in the meeting.

- D. Approve the Housing Rehabilitation Program Guidelines with the proposed modifications;
