Architectural and Site Plan Review #24-A08. Review of Proposed Exterior Remodel in a
 Historic District of the Existing Single-Story Residence Located at 245 West Eleventh Street –
 Applicant – Laura Cayley, Property Owner

Assistant Planner Goose presented a PowerPoint presentation and addressed Commissioners' inquiries regarding approval of vinyl clad wood framed windows in the immediate area, definition of this home as being craftsman style, the viability of the porch expansion for outdoor activities, the exterior of the building due to its disrepair, the setback reduction being common in the neighborhood, the recommendation to the applicant to use aluminum clad wood, the framing to the front wall, the setback reduction permit requirements, and the French doors being salvaged.

There was no applicant presentation.

Vice-Chair Castillo invited public comment.

There were no requests to speak.

Vice-Chair Castillo closed public comment.

Commissioner Spivack approves of the plan. She is in favor of not using vinyl in the historic district since the windows can be salvaged. She likes the continuity for use of wood. She agrees with the setback and porch design.

Commissioner Perry does not appreciate the porch design, as the massive size does not compliment the building. He noted that a porch with a wood face is a better approach. He would like to see accent colors added to upgrade the personality of the home. He discusses how landscaping needs to be reconsidered in this project; suggesting that two additional silky oak trees may need to be removed as they were out of scale for the home and that the proposed plants, a disjointed mix of desert and riparian plants, be replaced with more organized plantings including hedged shrubs that would better suit the character of the home. He would like Staff and the applicant to take his comments into consideration in their interactions.

Commissioner Bennett would like to see design elements indicating that the front door is directly at the top of the stairs. He agrees with Commissioner Perry regarding the usage of

wood composite siding for the porch rather than field stone due to its low maintenance and cost effectiveness.

Vice-Chair Castillo is fine with the proposal. She agrees with Staff on the Certificate of Appropriateness and does not think it will have negative impact to the neighborhood. She does not oppose the design, but she thinks the comments from the other Commissioners should be taken into consideration for a better design.

Commissioner Spivack agrees with Commissioner Perry regarding the color scheme. Bringing in brighter colors would provide contrast and add interest to the home without a lot of expense.

Commissioner Perry moved to Adopt a RESOLUTION OF THE ARCHITECTURAL AND PRESERVATION COMMISSION OF THE CITY OF CLAREMONT APPROVING ARCHITECTURAL AND SITE PLAN REVIEW #24-A08, REVIEW OF PROPOSED EXTERIOR REMODEL IN THE HISTORIC CLAREMONT DISTRICT OF AN EXISTING SINGLE-STORY RESIDENCE LOCATED AT 245 WEST ELEVENTH STREET. LAURA CAYLEY with amended conditions of approval encouraging the applicant to work with staff to: revise the paint colors, retain wood windows, install new wood windows were warranted, modify the landscape plan to address concerns from the Commission, and simplify the porch to resemble more of a wood structure with less stone; and find this item is exempt from environmental review under the California Environmental Quality Act (CEQA). Seconded by Commissioner Spivack; and carried on a roll call vote as follows:
