A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF CLAREMONT, CALIFORNIA, AUTHORIZING THE SUBMITTAL OF THE 2024-25 TRANSPORTATION DEVELOPMENT ACT – ARTICLE 4, STATE TRANSIT ASSISTANCE, SENATE BILL 1 STATE TRANSIT ASSISTANCE, AND SENATE BILL 1 STATE OF GOOD REPAIR CLAIMS FORMS TO RECEIVE CAPITAL AND OPERATING FUNDS

WHEREAS, the Transportation Development Act (TDA) is created pursuant to Public Utilities Code (PUC) Section 99200 *et seq.*, provides for the disbursement of funds from the Local Transportation Fund (LTF) for use by eligible applicants for the purposed of providing public transportation services; and

WHEREAS, the State Transit Assistance (STA) Fund is created pursuant to Public Utilities Code Section 99310 *et seq*. making funds available pursuant to PUC Sections 99313.6 for allocation to eligible applicants to support approved transit projects; and

WHEREAS, the City of Claremont is an eligible recipient of Senate Bill 1 (SB1) State Transit Assistance (STA) and State of Good Repair (SGR) funding; and

WHEREAS, the Claremont City Council has adopted a budget for the Claremont Dial-A-Ride and Get About transportation programs for 2024-25 evidencing a need for financial assistance; and

WHEREAS, the Southern California Association of Governments (SCAG) has been charged with the responsibility for allocating the funds; and

WHEREAS, the Los Angeles County Metropolitan Transportation Authority (LACMTA) serves as the regional planning agent for the Los Angeles County, and administers and processes the funds to each participating municipal operator.

NOW, THEREFORE, BE IT RESOLVED, DETERMINDED, AND ORDERED by the City Council of the City of Claremont, California, as follows:

SECTION 1. The above recitals are true and correct and incorporated herein.

SECTION 2. The City Council authorizes and directs the City Manager or his/her designee to execute and file a claim with LACMTA for TDA in the amount of \$929,842, and to take any and all necessary further actions and execute any and all necessary documents in order to receive and/or reserve such funds; and

SECTION 3. The City Council authorizes and directs the City Manager or his/her designee to execute and file a claim with the LACMTA for STA funds in the amount of \$ 29,426 and to take any and all necessary further actions and execute any and all necessary documents in order to receive and/or reserve such funds.

SECTION 4. The City Council authorizes and directs the City Manager or his/her designee to execute and file a claim with the LACMTA for Senate Bill 1 STA funds in the amount of \$22,319 and to take any and all necessary actions to execute any and all necessary documents in order to receive and/or reserve such funds.

SECTION 5. The City Council authorizes and directs the City Manager or his/her designee to execute and file a claim with the LACMTA for SB1 - State of Good Repair funds in the amount of \$ 5,601 and to take any and all necessary further actions and execute any and all necessary documents in order to receive and/or reserve such funds.
